

## City of Fayetteville Application Form For Appointment to Boards, Commissions and Committees

The City Council has adopted a “policies and procedures” statement in order to:

1. Provide a broad cross-section of qualified individuals for service on the appointed bodies.
2. Provide an opportunity for participation in city affairs by interested citizens.
3. Provide a means for full City Council involvement.

Applications for appointments come from two principle sources:

1. Advertisements for open positions are run on the Fayetteville Government Channel Cox Channel 216 & AT&T Channel 99.
2. City Council members, city staff members, interested organizations and individuals who know of qualified persons often encourage them to apply for appointment.

Upon receipt of the completed application form, the City Clerk office forwards a copy of the application to the City Council Nominating Committee.

The City Council Nominating Committee then sets a time for personal interviews, conducts the interviews and makes a recommendation for each appointment. The City Council makes the final selection in open session, for most boards. Some appointments are made by the Mayor or the board members.

If you are applying for the Advertising & Promotion Commission, City Board of Health, Historic District Commission, Housing Authority Board, or Library Board, you may or may not be called for an interview by the City of Fayetteville Nominating Committee.

**The qualifications for serving on a city board, committee or commission was revised and adopted July 2, 2019, Ordinance No. 6196.**

The following criteria shall be considered in making appointments. However, differences in appointive bodies, the relative importance assigned to various criteria will vary with different appointments. For example, the Planning Commission appointments should emphasize experience and expertise in the subject matter.

1. Expertise, experience and interest in the subject matter.
2. Attendance at a meeting of the committee is recommended prior to application. Meeting times and locations for board and committees can be accessed at the following link <http://www.fayetteville-ar.gov/494/Boards-Committees-Commissions>
3. Balance of appointive body.
4. **City Code 33.329 - Eligibility Of Resident Volunteers To Serve On City Boards, Commissions And Committees (A) All Fayetteville residents who are legally authorized to live or work in the United States shall be entitled to apply and, if selected by the City Nominating Committee and approved by the City Council, shall be entitled to serve on a city board, commission, or committee. Exceptions. Only registered voters within the corporate limits of Fayetteville shall be eligible to serve on the following boards, commissions or committees: Fayetteville Public Library Board of Trustees, Historic District Commission, Northwest Arkansas Regional Airport Authority, Planning Commission, Civil Service Commission and Energy Improvement District No. 1**  
**Any person serving on a board, commission or committee who moves out of Fayetteville or violates the Rules of Conduct or Attendance Requirements shall no longer be eligible to serve.** Public Facilities Board appointees do not have to be citizens of Fayetteville according to State Statute 14-137-108.
5. Any citizen volunteer member of any City board, commission or committee who fails to attend at least 70% of all meetings of that committee within a twelve-month period of service shall be deemed to have resigned from the board, commission or committee and that person's position shall be deemed vacant.
6. Willingness to serve.
7. Specific criteria as established in the ordinance or resolution establishing such board or commission.

Any person who has served two consecutive full terms on any citizen board, commission or committee is not eligible for re-appointment to the same group until one term of office has expired, unless there are an insufficient number of qualified applications to fill all vacancies.

Applicants applying for the Civil Service Commission must be a resident of the city for at least three years immediately preceding their appointment. (State Statute §14-51-202). Commission meetings generally are held during normal business hours 8:00 a.m. to 5:00 pm.

The term limits for the Public Library Board of Trustees follow Arkansas law governing municipal library operation. (State Statute §13-2-502)

When vacancies on the Planning Commission occur because of resignation or term expiration, the applicant shall follow the following procedure:

Applicants shall disclose all real estate holdings in Fayetteville and the Fayetteville planning area, and any business or financial interest which could affect, or be affected by, decisions of the Planning Commission. (City Code Sec. 33.110)

1. Have you applied to be on this board, commission, or committee in the past, or are you currently on it? Why do you want to be on this committee or why do you want to be reappointed?
2. What are your qualifications? What do you think makes you the best candidate?
3. Have you attended the committee meetings in the past? If you have served on the committee, what did you enjoy the most about serving?
4. Do you understand the time commitment if selected and do you have time to commit to the committee? If you have served on the committee, did you attend regularly?
5. If you are appointed, what changes or improvements would you like to see? What do you hope to contribute and how would you work to see those changes, improvements, or ideas implemented?
6. How has your experience (job, volunteer work, interests) prepared you for future issues on which this committee will be working?
7. What is the description of this committee?
8. When does this committee meet?
9. Do you understand the role of this advisory committee?
10. Do you have any questions for us?
